 - a. We are unable to do so prior to bid submission.
- 2) Why is ELCLC going out bid for auditing services?
 - a. Due to state procurement requirements, we must request bids for services every three years.
- 3) Is the prior year auditor able to propose?
 - a. Yes.
- 4) Has anything significant occurred in the current year, which is different from prior years? Is something significant expected and/or budgeted to occur in the current year, or soon thereafter, which a potential auditor should be aware of?
 - a. In the current fiscal year, we have received ARPA Grant funding, which is a onetime state legislative allocation for Early Learning Coalitions.
- 5) What has been exhibited by the current auditors that ELCLC values the most?
 - a. Understanding of the federal and state requirements involved in the single audit process.
- 6) Please provide a copy of ELCLC's FYE 6/30/23 and 6/30/22 budgets.
 - a. These will be provided to the selected bidder.
- 7) Please provide a copy of ELCLC's most recent internal financials (balance sheet, income statement, budget vs actual, any other relevant financial reports).
 - a. These will be provided to the selected bidder.
- 8) Please provide a listing of schedules/workpapers provided to the prior auditor.
 - a. These will be provided to the selected bidder.
- 9) Please provide the audit adjustments (proposed and posted) for 6/30/22 and 6/30/21 audits.
 - a. These will be provided to the selected bidder.
- 10) Please provide the audit and tax fees for 6/30/22 and 6/30/21 FYE audits and IRS Form 990.
 - a. These will be provided to the selected bidder. The 990 has been uploaded.
- 11) The new ASC 842 Leases will be applicable for the FYE 6/30/2023. Will ELCLC calculate and record the lease liabilities and right to use asset and related amortizations or will the auditor be engaged to provide this non-audit service?
 - a. The auditor will be contracted to provide this service.

- 12) Is ELCLC drafting the financial statements, notes to financial statement, and schedule of expenditures of Federal Awards and State Financial Assistance? or is this outsourced as a non-audit service to the auditor?
 - a. This is contracted to the auditor to provide this service.
